Motion made by Kelly and 2nd by Ellison to add minimum parking to table of use under kennels and veterinary clinics with outdoor runs. This standard to be the same as medical clinics pg. CD:36:86 sec. 36-2763 #16. Motion carried.

Motion made by Ellison and 2nd by Bouvy to add minimum parking to table of use pg. CD:36:62 section 36-179 under security buildings or construction offices. This standard would be the same as public utilities facilities pg. CD:36:66 sec, 36-179. Motion carried.

Motion made by Kelly and 2nd by Bouvy to change parking for launderette from one space per two machines to one space per three machines pg. CD 36:86 #13. Motion carried.

Motion made by Kelly and 2nd by Bouvy to allow up to three years to pave parking lot at 2200 S. Reese Rd. Parcel #06-12-6-13-1015-002 (rental hall) from the date the zoning permit is issued. Minimum # of parking spaces for this location is 38 spaces. Motion carried.

Motion made by Bouvy and 2nd by Toloff to have planning commission meeting the 1st Tuesday of the month. Motion carried.
