Ongoing Business:

Accessory Building Ordinance Changes from November 01, 2021. Made review of changes and approved. Motion made by Kelly and 2nd by Ellison to send the following accessory building ordinance changes to the Reese Village Council for approval and placement to the Village Ordinances. Motion approved.

Accessory Building Ordinance Corrections/Changes:

- a. Zoning – CD36:cd36:71 – Sec. 36-186 Schedule of Regulations remain the same with changes being made to Footnotes to Schedule of Regulations as follows.
 1. Footnote “I” – The maximum size of an accessory structure shall be 1200 square feet and less than 25% of the property.
- b. Zoning – CD36:74 – Sec. 36-212 Scope of District Regulations paragraph “J” remains the same.
- c. Building Height being the vertical distance from the grade at the center of the front of the building to the highest point of the roof surface between eaves and ridge for gable, hip, and gambrel roofs maximum of twenty-three feet.
- d. If there is more than a two-foot overhang on any one side of the accessory building it will be required that overhang will be included as part of the square feet of the accessory building.

New Business:

Request from the Reese Fire Department to regulate fire ring/pit size within the Village of Reese. Suggested size being 48” across for ring and 48” x 48” inside distance for a square pit. Discussion held and size recommendations made by Reese Fire Department approved. Motion made by Kelly and 2nd by Ellison that the following changes be added to the Village of Reese Ordinance. 48” across for fire ring and 48” x 48” inside distance for square fire pit. Motion approved.

Items for Discussion:

Who is responsible to report items being built/installed within the Village of Reese that may be questionable as to having proper approval or in accordance with village ordinance requirements? Village Manager will report at next meeting.
